### **Scope and Content Note**

Records primarily consist of subject files. These are arranged alphabetically and include correspondence, notes, printed items, agenda, clipping, and reports pertaining to various petrochemical plants, Calcasieu Parish, officials, environmental groups, the effect of the environment on health, legislation, regulation, or government agencies. Additionally, the organization's general correspondence, minutes, and agendas are present, as well as newspaper clippings and newsletters they received. Results of environmental testing are also included.
